Wilkes-Barre Area Career and Technical Center Cafeteria Policy – 2025-2026 School Year

The Wilkes-Barre Area Career and Technical Center, (WBACTC), will continue to participate in the "Community Eligibility Program" or "CEP" for the 2025-2026 School Year. This program has allowed the school to provide a "FREE" breakfast and/or lunch to <u>ALL</u> students regardless of the family income.

According to the USDA Food and Nutrition Service, the requirements for a reimbursable meal in Offer vs. Serve are as follows. "At lunch, schools must offer students all five required food components in at least the minimum required amounts. The components at lunch are: meats/meat alternates; grains; fruit; vegetables; and fluid milk. Under OVS, a student must take at least three components in the required serving sizes. One selection must be at least ½ cup from either the fruit or vegetable component." "At breakfast, schools must offer students all three required food components in at least the minimum required amounts. The components at breakfast are: grains (with optional meats/meat alternates allowed); juice/fruit/vegetable; and milk. Under OVS, a student must be offered at least four food items and must select at least three food items, one of which must be ½ cup of fruit or vegetables for OVS."

The student will be charged as ala carte and must pay cash if the breakfast and/or lunch meal does not consist of at least 3 components.

Parents may still place money on the student's cafeteria account to pay for extra food or ala carte items. If there is no money in the account, the student must pay cash for any additional items. There will be no charges allowed to any accounts.

Paper applications <u>will not</u> be processed at the (WBACTC) – <u>all students are "FREE"</u>. PLEASE NOTE: The home school may still require the student to submit an application.
