1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
 - a. *HEERF I Certification and Agreement, signed on April 28, 2020 was submitted via grants.gov on May 5, 2020.*
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
 - a. *HEERF I was submitted to grants.gov for Wilkes-Barre Area Career & Technical Center Practical Nursing Program to receive \$167,531.00.*
 - b. *HEERF I was received in Wilkes-Barre Area Career & Technical Center Practical Nursing Program's G5 account on June 4, 2020 (P425E204170).*
 - c. *HEERF II was received in Wilkes-Barre Area Career & Technical Center Practical Nursing Program's G5 account on March 21, 2021 (P425E4170) in the amount of \$167,531.00.*
 - d. *HEERF III was received in Wilkes-Barre Area Career & Technical Center Practical Nursing Program's G5 account on June 9, 2021 (P425E4170) in the amount of \$525,296.00.*

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).
 - a. *HEERF I was disbursed in full to students on June 11, 2020.*
 - b. *All the HEERF I funds, \$167,531.00 were disbursed.*
 - c. *HEERF II funds of \$167,531.00 were disbursed in full to students on April 20, 2021*
 - d. *HEER III funds of \$51,200.00 were disbursed on October 18, 2021 and \$128,650.00 were disbursed on October 22, 2021.*
 - e. *HEERF III funds of \$197,400.00 were disbursed January 25, 2022 and \$141,400.00 were disbursed on February 2 and February 8, 2022.*
4. The estimated total number of students at the institution who are eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
 - a. *HEERF I funds, \$167,596.00, were divided equally to the 143 students who applied and were eligible for the grant.*
 - b. *Each student received \$1,172.00. Each student was sent a check on June 11, 2020.*
 - c. *HEERF II funds, \$167,531.00, were disbursed by check to 103 students who met the eligibility requirements.*
 - d. *Pell eligible students received \$1,700.00 and non-eligible students received \$1,200.00 from HEERF II.*
 - e. *HEERF III funds totaling \$179,850.00 were disbursed by check to 101 eligible students. 81 Pell eligible students receiving \$1,850.00 and 20 non-Pell eligible students receiving \$1,500.00.*
 - f. *HEERF III funds totaling \$388,800.00 were disbursed to 56 eligible students: \$197,400.00 – 49 Pell eligible students received \$3,600.00 and 7 non-Pell eligible students received \$3,000.00. \$141,400.00 – 51 Pell eligible students received \$2,600.00 and 4 non-Pell eligible students receives \$2,200.00.*
5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.
 - a. *143 students received the HEERF I grant.*

- b. 103 students received the HEERF II grant.*
 - c. 101 students received the HEERF III grant.*
 - d. 56 students received the HEERF III grant.*
- 6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.
 - a. Students received an email with the details.*
 - b. HEERF I funds were divided equally as it was determined that all applicants were financially impacted by COVID-19.*
 - c. Students needed to:
 - 1. Submit an application (only for HEERF I)**
 - d. HEERF II and HEERF III funds were disbursed with Pell eligible students receiving additional funds.*
